# MOCK TRIAL TEAMS TAKE THE STAND 

Set-up in a mock court room in Grand Island's Federal Building, GICC's two Mock Trial teams competed in three competitions 0ct 25, 0ct 30, and Nov 8.

The GICC 1 team beat both Axtell and Kearney High, and tied with Gibbon (last year's Regional winner). While the GICC 2 team tallied a win against Axtell, but fell to both Gibbon 2 and Kearney Catholic.
"I am so proud of how hard the kids have worked and how much progress we have made since the beginning of the year," Anna Brokaw, who co-coaches with AI Corey, said.

Based on win/loss record, number of judge ballots, and cumulative scoring, two teams from the regional will earn rights to compete in the Regional Finals before Thanksgiving. The coaches are still awaiting the final results to know if GICC 1 will advance to the finals.

The case this year is a criminal case brought by the federal government against Higgs Schrodinger, an introverted college student. Higgs has been accused of sharing a photograph containing confidential information that relates to national security. Both teams have had to compete as the government and as defense counsel for Higgs.
"Having two teams this year made practice interesting because we basically competed
against each other in practice," GICC Senior Carreagan Endorf said.

Coaches Brokaw and Corey formed the two teams by considering experience, skill, and what roles each student might fill.

No matter the results of the upcoming Regional competition, the coaches are excited about the future of Mock Trial at Central Catholic.
"We still are a very young group, mostly freshmen and sophomores, so the future of mock trial at GICC is very bright," Coach Brokaw commented. "I look forward to a lot of success with these kids in the years to come. "
