You have the opportunity to decrease your tuition balance at Central Catholic! And you don't have to sell anything to anyone! This program is based on retail rebates, and it's easy to use!

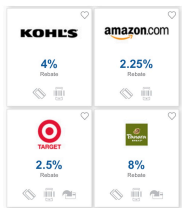


How it Works:

You and your family members purchase gift cards via your computer or mobile phone. The 750+ retailers available indicate the percentage of rebate offered. When purchased, that rebate is sent to GICC to be directly applied toward YOUR family's tuition balance! A few bucks here, and a few bucks there will add up, and you'll get all of that savings!

Buy e-cards or physical gift cards via RaiseRight



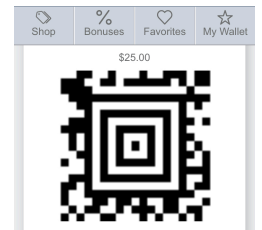
Pay online directly from your bank account or with a credit card

Enroll Now:

STEP 1: Fill out the GICC RaiseRight Participant Agreement and either submit it to the school office or email it our representative Valerie Chmelka at vchmelka@gmail.com. You will then be given an enrollment code.

STEP 2: Go to the raiserright.com website. Click **Sign Up**. Enter the enrollment code and click **Join A Program**.

STEP 3: Complete your account and password set-up, and link your checking account or credit card (2.6% fee applies).

STEP 4: Register your mobile phone & download the **RaiseRight Fundraising app**, or shop directly from the website. Happy shopping! Happier SAVING!

PLEASE NOTE... The "Pay Coordinator Directly" & "Ship To My Coordinator" features are not supported by GICC. Selecting these options during your order will result in your order being canceled manually after it's placed online.



Frequently Asked Questions

Is my family required to participate in this program ?

No. Participation is completely voluntary.

Why is GICC using the Tuition Savings While You Shop Program?

We want to help families of all economic backgrounds more-easily afford GICC tuition. By offering this program, we are providing families a way to get credits to their tuition accounts without having to sell anything to anyone. There are no committee meetings, no door-to-door sales, no volunteer shifts just families spending the same amount of money they would normally spend at a select group of retailers!

Can my relatives nation-wide use RaiseRight and apply their rebates to my family's tuition account?

Yes! By following the GICC enrollment instructions, relatives, friends, neighbors, coworkers, etc can all use RaiseRight and designate YOUR tuition account as the rebate benefactor. All rules and policies within our GICC plan will apply.

Can we order physical gift cards?

Yes, you can now order physical gift cards as long as you use the "Ship Them To Me" option. Additionally, if our Tuition Savings While You Shop volunteers are able, we will offer an annual order form for physical gift cards around Christmas for those families wishing to have physical cards to give as gifts. For that order ONLY, checks will be accepted and required as payment. All families would be welcome to use that 1-time order form. A \$1.50 shipping fee will be applied.

What happens if I accidentally or intentionally "Ship To My Coordinator" or select "Pay Coordinator Directly?"

Due to a failsafe in our GICC RaiseRight account, these orders will not process or ship.

If you selected "Ship To My Coordinator" and paid instantly with a bank transfer or credit card, you can request a cancellation & refund by contacting our representative listed below to explain your situation and request the cancellation when it's convenient for the representative. Upon receipt, your refund will apply to your tuition account, not to your checking or credit card account.

How do I know that my rebates are credited to my family's tuition account?

The rebates you accumulate are applied to your tuition account (or that of a designated family) in January & July per your allocation. You will see these credits listed on the tuition invoices.

Does GICC keep any of the rebate money?

No. GICC is offering Tuition Savings While You Shop as a family tuition-relief program. The school will not retain any portion of your rebate unless one of these circumstances apply: (1) your student transfers out of GICC [or fails to ever enroll at GICC in the case of new incoming students] which forfeits all accumulated rebates; (2) your youngest student graduates which forfeits rebates accumulated after the January deposit of that student's senior year; or (3) your family selects that your rebates be deposited into the general tuition assistance fund in lieu of your own tuition account. Rebates retained by GICC will be deposited into the general tuition assistance fund for use as tuition discounts offered to needy families.

Can I use RaiseRight during summer to build-up deposits to my tuition account for next school year?

Yes! We recommend that families use our Tuition Savings While You Shop program year-round to continually contribute to their tuition accounts. Families of current 5th graders and future transfer students can even participate to start building funds in their future tuition accounts.

Is RaiseRight a secure service?

Yes. Transactions are encrypted, and use the same Automated Clearing House (ACH) process as direct deposits and Social Security.

Grand Island Central Catholic (referred to herein as "we," "us" and "our") sponsors a tuition-relief program that allows you to purchase e-gift cards. The e-cards you purchase through us generates rebates from the participating retailers. These rebates will be used as a credit to your family's/another family's tuition account and/or a gift to the school's general tuition assistance fund. The parties agree as follows:

Our Tuition Savings While You Shop program distributes the rebates to the designated tuition account(s) 2 times per year in the months of July and January. We will offer a physical gift card order for the holidays. These orders will require \$1.50 for shipping per purchaser.

With respect to your charitable contributions, we will provide you with all required acknowledgements under sections 170(f)(8) and 170(f)(17) of the Internal Revenue Code.

You agree to indemnify us against any loss incurred in connection with insufficient funds in your account to cover the checks of ACH transfers you issue to pay for your gift cards. We make no representations or warranties of any kind with respect to RaiseRight. Any insufficient funds accrued will be at a \$35 charge to your tuition account. Creating 2 overdrafts within a 12-month period revokes your Tuition Savings While You Shop and RaiseRight privileges.

This agreement continues unless replaced by another, and can be terminated by either of us upon 60 days notice to the other. If you no longer choose to participate with RaiseRight you can discontinue at any time, but we will be unable to issue a refund. Any remaining funds on your account will be applied to the school's general tuition assistance fund.
